PARADE RULES



Planning Your Entry

1. Entries should reflect a holiday theme.
2. Santa entries are not allowed because the real Santa Claus agreed to participate.
3. Music must be appropriate for all ages.
4. Sound systems may not be used for addressing the audience (no speech/campaigning)
5. Air horns and sirens are not permitted unless by the Fire, Police or EMS Department. Sirens, horns and any other audible devices not playing Christmas music should only sound in 2 to 3 second increments no more than once a minute.
6. Animal Entries (includes horses) MUST have a clean-up crew or will not be permitted to participate.
7. Do not throw candy.
8. You will be called if the parade is postponed or cancelled. You may check the weather line at (910) 893-0338 for updated weather related news on the day of the parade.

Before & After the Parade:

1. The line-up area will open at 5:00 p.m. The entrance for line-up will be at the intersection of James St. and Main St.
2. No vehicles will be allowed to enter the parade line-up after 6:00 p.m.
3. Each entry will be assigned a number that is your place in the line-up. The number and a map showing your placement will be given to you at the entrance point on parade day.
4. Numbers will be marked along James St. and 10th St.
5. Only floats/vehicles driven in the parade are permitted to enter and park in the line-up areas.
6. Floats/vehicles not in the parade may park at Star Academy or the Harnett Board of Education parking lots.
7. All parade floats and participants will turn off to the right on Lofton Street at the end of the parade.

Judging:

1. Judges will evaluate the entry's detail, difficulty of construction, color and originality of the entry.
2. All entries that have asked to be entered into the float judging contest will be judged during the parade at a fixed location on either Front or Main Street.
3. There will be a 1st, 2nd and 3rd place overall winner. Winners will be announced by Friday, December 20th. Winning entries will be contacted via phone and the winners will be announced on the Town of Lillington Parks & Recreation Facebook page and website. Winners will receive a plaque to display at their business or organization.

Release
