Item #7 Consideration of Approval of Agreement for Fire Protection Services Between the Town of Lillington and Harnett County

Mayor McFadden recognized Joseph Jeffries, Town Manager. Mr. Jeffries stated this is an agreement between the Town of Lillington and Harnett County to provide fire protection services, facilities, and functions pursuant to the standards set forth by the North Carolina Department of Insurance, County of Harnett, and all other pertinent federal, state, and local laws and regulations within the boundaries of the Flatwoods/Lillington Fire Protection Service District. Mr. Jeffries stated this is an annual contract.

A motion was made by Commissioner Johnson to approve the Agreement for Fire Protection Services between the Town of Lillington and Harnett County. The motion was seconded by Commissioner Page and approved unanimously.

Item #8 Consideration of Approval of Temporary License Agreement Between the Town of Lillington and Hanson Aggregates Southeast LLC for Emergency Water Source for the Town of Lillington Fire Department

Mayor McFadden recognized Joseph Jeffries, Town Manager. Mr. Jeffries briefed the Board that this is an agreement between the Town of Lillington and Hanson Aggregates Southeast LLC for Emergency Water Source for the Town of Lillington Fire Department. Use of the pond satisfies an insurance requirement of the Lillington Fire Department of needing a water source within 1000' of any inhabited structure. In addition, the use of the pond also provides the Fire Department a remote fill station in case of emergency.

A motion was made by Commissioner Page to approve the Temporary License Agreement between the Town of Lillington and Hanson Aggregates Southeast LLC for Emergency Water Source for the Town of Lillington Fire Department. The motion was seconded by Commissioner Phillips and approved unanimously.

Item #9 Consideration of Approval of Grantee Acknowledgement and Agreement Between the Town of Lillington and The Golden LEAF Foundation

Mayor McFadden recognized Joseph Jeffries, Town Manager. Mr. Jeffries explained this is an agreement between the Town of Lillington and The Golden LEAF Foundation to accept the funding requested in the Grant Application submitted to Golden LEAF for the Lillington Front Street Repair reimbursement and sewer system assessment.

A motion was made by Commissioner Page for the Approval of Grantee Acknowledgement and Agreement Between the Town of Lillington and The Golden LEAF Foundation. Motion was seconded by Commissioner Langdon and approved unanimously.
